



Memorandum of Understanding

between

Chitkara University

and

Rider University

THIS MEMORANDUM OF UNDERSTANDING ("MOU"), dated April 15, 2021, between Chitkara University(herein read as "CU"), with an address at Chandigarh-Patiala National Highway, NH-64 Village Jansla, Rajpura, Punjab 140401, and Rider University ("RIDER"), with an address at 2083 Lawrenceville Road, Lawrenceville, NJ, USA 08648 (CU and RIDER, each individually a "Party", and collectively the "Parties"),

Whereas Chitkara University ("CU") and Rider University ("RIDER") desire to work together to develop institutional and educational linkages between the two campuses for the purposes of:

- A) Offering a path to the RIDER undergraduate and graduate business degrees for CU students;
- B) Acceptance of CU students into RIDER's undergraduate and and graduate degree programs;
- C) Participation in collaborative professional development and training initiatives;
- D) Participation in collaborative research and development projects;

WHEREAS, the Parties desire to memorialize the terms and conditions of their cooperation;

Therefore, it is agreed that CU is authorized to promote the RIDER Undergraduate and Graduate Business Degrees, using the promotional means best suited for that purpose in accordance with the terms of this Memorandum of Understanding ("MOU").





CU will select and refer students to RIDER for enrollment when under the following conditions:

- CU will adequately consult with and advise qualified students to apply to RIDER and
 ensure that they are fully aware of the educational possibilities available to them, together
 with all information regarding all fees, terms of payment, commencement dates, and
 requirements for admission into any course and/or program of study at RIDER. Schedule
 A of this MOU contains the undergraduate and graduate admission requirements.
- 2) CU will promote RIDER's undergraduate and graduate business programs by:
 - a. Introducing RIDER to qualified CU students and their families;
 - b. Organizing seminars and presentations to eligible CU students.
- 3) CU is authorized to provide information on RIDER's courses and recruit students for RIDER through its promotion. During the Term of this MOU, RIDER gives CU explicit permission to announce its affiliation with RIDER. Furthermore, for the term of this MOU, RIDER gives CU a limited license to include the RIDER logo, pictures of RIDER, and information about RIDER in CU marketing materials, both print and digital. RIDER reserves the right to review and exclude RIDER logo, pictures, and information from use in CU printed and digital media.
- 4) RIDER will provide CU with information such as college catalogs, course descriptions, brochures, etc., with preference to digital materials. CU acknowledges that RIDER asserts copyright and trademark/service-mark rights in all such materials and shall treat them in compliance with India, USA, and international copyright and trademark laws.
- RIDER will assist CU applicants in obtaining student visas from the US Consulate General.
- 6) The tuition fees, room and board, compulsory fees such as insurance and deposit (to be paid in US Dollars) will be paid directly to RIDER by CU students. The rate of tuition and room and board and fees will be reviewed annually. RIDER will share new rates with CU at least four (4) months in advance of RIDER's fall semester. RIDER will provide academic scholarships to all eligible and qualifying CU students and will share scholarship information and qualifications with CU at least four (4) months in advance of RIDER's fall semester. Schedule B of this MOU contains information on RIDER's tuition and fees.





- 7) TERM OF THIS MOU: This MOU is valid for the 2021-2022 Academic Year, and upon expiration, shall automatically renew for a period of five (5) Academic Years. Either Party May decide to terminate this MOU by written notice of termination to the other Party upon at least six (6) months' notice.
- 8) The specific activities developed in order to achieve the proposed aims will be determined for each occasion by means of specific implementing agreements, according to the availability of resources.
- 9) This MOU represents the full understanding of the Parties to date. All amendments to this MOU and all implementing agreements entered under this MOU must be in writing and signed by both Parties.
- 10) The Parties acknowledge that they are and shall remain independent legal entities, and that this MOU does not create an employment or agency relationship and that neither Party is empowered to legally bind the other, unless specifically authorized to do so in a subsequent implementing agreement.
- 11) The Parties intend to resolve any disputes arising under the MOU and/or any implementing agreement amicably. If the Parties cannot reach a mutually-satisfactory resolution between themselves, they will submit the matter for arbitration and the rules of the New York Arbitration Convention shall apply. Each Party shall bear its own costs and half of any arbitration fees. The proceeding shall be conducted in English and take place in the State of New Jersey, USA. Such arbitration award shall then be the final, binding, and exclusive remedy for the Parties.
- 12) The MOU shall be governed by the laws of the State of New Jersey, USA, without regard to conflict-of-law rules when activities under it are conducted at RIDER and the laws of INDIA without regard to conflict-of-law rules when conducted at CU.

Academic Year 2021/2022

Undergraduate Admission Requirements

CU students applying for RIDER's undergraduate programs will need to submit the following for admission consideration:

- The RIDER online application
- Official transcripts from CU, in English
- Evidence of at least a 2.5 cumulative grade point average (GPA) on the US 4.0
 GPA scale
- Official transcripts from other tertiary educational institutions, if the CU student transferred to CU
- Letter of recommendation
- Personal essay (included as part of the online application)
- Proof of English Language Proficiency (minimum of 70 on the iBT TOEFL or
 6.0 on the IELTS or 95 on the Duolingo)
- Proof of finances for one academic year of study by supplying (for I-20 purposes):
 - RIDER International Student Supplement
 - o Supporting financial evidence, such as a bank statement
 - Copy of the biographical passport page

Graduate Admission Requirements

CU students applying for RIDER's Graduate Business program will need to submit the following for admission consideration:





- The RIDER online application
- · Official transcripts from CU, in English
- Certified copy of the Baccalaureate (or equivalent) transcript. If degree conferred
 not on transcript, then a certified copy of the Baccalaureate Degree or equivalent
 is required as well.
- Evidence of at least a 3.0 cumulative undergraduate grade point average (GPA)
 on the US 4.0 GPA scale
- Official transcripts from other tertiary educational institutions, if the CU student transferred to CU (in such cases, additional requirement for an official transcript evaluation may be needed, with a course by course evaluation conducted by a NACES member - www.naces.org/members)
- One (1) letter of recommendation
- Statement of Aims and Objectives
- Resume (if applying graduate business programs)
- Official notification of GMAT or GRE scores, if waiver not granted. Waiver requirements are either 3.0 or better undergraduate cumulative GPA for MSIS and MBA; or five (5) years professional work experience (No GMAT/GRE needed for MAcc).
- Proof of English Language Proficiency (minimum of 79 on the iBT TOEFL or
 6.5 on the IELTS), if undergraduate degree not obtained from RIDER
- Proof of finances for one academic year of study by supplying (for I-20 purposes):
 - o RIDER International Student Supplement
 - o Supporting financial evidence, such as a bank statement
 - Copy of the biographical passport page
