The invention relates to a method and therapeutic formulation for treating stress-induced neurobehavioral disorders using Suramin. The therapeutic formulation is designed as a sublingual film that includes Suramin, a watersoluble polymer, a plasticizer, and pharmaceutically acceptable excipients. This formulation aims to address chronic stress-induced neuroinflammation and synaptic dysfunction, leading to improved neurobehavioral outcomes, reduced neuroinflammation, enhanced synaptic integrity, and better mood and cognitive functions.
